5. Staff Sergeant Report

Staff Sergeant Ouellette drew to the attention of the board the copies of press releases that have been issued since the last meeting. He indicated that there has been a spike in break and enters however on a year to date basis we are on par. Overall it has been a steady couple of months. There have been a few copper thefts during break and enters. One arrest has been made in that area.

Staff Sergeant Ouellette indicated that a break in on Buck Lake had occurred and that this was the new residence of the Kingston Chief of Police.

He indicated that over the next week staffing will be reduced as twelve members have gone to the G20 Conference to offer additional support. Schedules will be back filled with over time and a cancellation of all leaves during that period.

Mayor Davison brought forward concerns with regard to a recent bout of vandalism at both the Point and Ken Garrett Park. He asked what level of police presence is involved in parks as well as how often officers are involved in foot patrols.

Staff Sergeant Ouellette felt that foot patrols happen quite a bit however they are limited to day time hours and generally vandalism does not occur when the police are present on foot.

Staff Sergeant Ouellette confirmed that cell phone use while driving has not been declining as a result of the recent legislation and that actual charges are taking place at this point in time.
